

Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025

An internal notification in my even letter number dated 19.09.2025 regarding above competitive examination in my even letter number dated 19.09.2025 has been published on the website of www.psc.cp.gov.lk, fixing the closing date of application as on 21.10.2025.

02. However, since officers in Grade II of Central Provincial Management Officers' Service who have promoted to the Grade II of Management Officers' Service but have not passed the Grade II of Central Provincial Management Officers' Service efficiency bar examination for not conducting relevant E.B. Examination in due time, could not apply for the relevant examination, Hon. Governor of Central Province has approved to provide opportunities for the officers in Grade II of Central Provincial Management Officers' Service who have applied for the E.B. Examination called in my letter No. CPC/PSC/6/MO/EB/2025 dated 05.08.2025, and have completed all other qualifications prescribed in the examination notification for Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025, to apply for the Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025 without causing injustice to them.

03. Moreover, I would like to inform you that officers who will appear and qualify for the Grade II E.B. Examination and qualify in the Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025 will be considered for appointment to Supra Grade based only on the number of vacancies and order of merits and further inform you that this concession should not be taken as an exemplary case for future cause and officers who apply for the E.B. Examination in Grade II of Central Provincial Management Officers' Service after 29.08.2025 as per my letter No. CPC/PSC/6/MO/EB/2025 dated 2025.08.05 will not be eligible for appointment under the Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025.

04. Accordingly, I do hereby inform you to take necessary measures to notify all the officers that closing date of the application for the Limited Competitive Examination for Promotion to the Supra Grade of Central Provincial Management Service Officers' Service – 2025 has been extended until 31.10.2025 while the others matters and conditions in the examination notice will be in force as it is.
